

The terms and conditions set forth below become part of the contractual agreement between Darwin Event Group and you, the EXHIBITOR. Acceptance of the said terms and conditions will be construed when any of the following are met:

- WHEN THE METHOD PF PAYMENT FORM IS SIGNED; OR
- WHEN AN ORDER FOR LABOUR, SERVICES, AND/OR RENTAL EQUIPMENT IS PLACED BY AN EXHIBITOR WITH DARWIN EVENT GROUP; OR
- WHEN WORK IS PERFORMED ON BEHALF OF EXHIBITOR BY LABOUR SECURED THROUGH DARWIN EVENT GROUP.

#### DEFINITIONS

The name "Darwin Event Group" shall be construed within the meaning of this contract as Darwin Event Group Inc (DEG) and its employees, officers, directors, agents and assigns, affiliated companies and related entities including by not limited to any subcontractors DEG may appoint.

The term "Exhibitor" shall be construed within the meaning of this contract as the Exhibitor and/or its employees, agents, representatives, and/or any Exhibitor Appointed Contractor (EAC).

#### PAYMENT TERMS

Full payment, including any applicable tax is due in advance or at the show site. All payments must be in Canadian funds and all cheques must be drawn on a Canadian Bank. Orders received without advance payment or after the deadline date will incur additional (After Deadline) charges as indicated on each order form. All materials and equipment are on a rental basis for the duration of the show or event and remain the property of DEG except where specifically identified as a sale. All DEG rentals include delivery, installation and removal from EXHIBITOR'S Booth. In case of cancellation, a one-hour, per-person, per-hour charge will be applied to all labour orders that are not cancelled in writing at lease 24 hours prior to the scheduled start time. If services have already been provided at the time of cancellation, a 30% restocking fee will be applied to all DEG rental items with the exception of Prestige Carpet, Custom-cut carpet, MIS Rental Exhibits and any other custom-order items, which will remain at 100% of the original charge. It is EXHIBITOR'S responsibility to advise DEG Exhibitor Services personnel of ay problem with the order, and to check invoices for accuracy prior to the close of the exhibit. If EXHIBITOR is exempt from payment of sales tax, DEG requires an exemption certificate for the Province in which the services are to be used. Resale certificates are not valid unless EXHIBITOR is rebilling these charges to its customers. For International EXHIBITORS, DEG requires 100% prepayment of advance orders and any orders or services placed at show site must be paid at the show. For all others, should there be any pre-approved unpaid balance after the close of the show; terms will be net, due and payable in Berwick, NS, upon receipt of invoice. Effective 30 days after invoice date, any unpaid balance will bear a FINANCE CHARGE at the lesser of the maximum rate allowed by applicable law, or 1.5% per month, which is an ANNUAL PERCENTAGE RATE of 18% and future orders will be on a pre-paid basis only. If any finance charge hereunder exceeds the maximum rate allowed by applicable law, the finance charge shall automatically be reduced to the maximum rate allowed, and any excess finance charge received by DEG shall either be applied to reduce the principal unpaid balance ore refunded to the payer. These payment terms and conditions shall be governed-by and construed in accordance with the laws of Nova Scotia in the event of any dispute between EXHIBITOR and DEG relative to any loss, damage, or claim, such EXHIBITOR shall not be entitled to and shall not withhold payment or any partial payment due to DEG for its services as an off-set against the amount of any alleged loss or damage. Any claim against DEG shall be considered a separate transaction and shall be resolved on its own merits. DEG reserves the right to charge EXHIBITOR for the difference between the EXHIBITOR'S estimate of charges and the actual incurred by EXHIBITOR, or for any charges that DEG may be obligated to pay on behalf of EXHIBITOR including without limitation any shipping charges.

#### OPTION A: LABOUR PROVIED UNDER THE SUPERVISION OF DEG

**RESPONSIBILITIES**: DEG shall be responsible for the performance of labour provided under this option. DEG cannot assume responsibility for any acts, or loss to persons, parties and/or other contracting firms not under DEG direct supervision and control. In no event shall DEG be liable for loss or damage caused by delay in labour beginning work when EXHIBITOR requests labour to begin later than the start of the working day. DEG shall not be responsible for loss, delay or damage due to strike, lockouts, and/or work stoppages, or other causes beyond DEG reasonable control.

**IMDEMNIFICATION**: DEG agrees to indemnify, hold harmless, and defend EXHIBITOR from and against all demands, claims, causes of action, fines, penalties, damages, liabilities, judgments, and expenses (including but not limited to reasonable attorney's fees and investigation costs) for bodily injury, including any injury to DEG employees, or property damage arising out of work performed by labour provided by and supervised by DEG, except when EXHIBITOR exercises direction and/or control over the work being performed.

#### OPTION B: LABOUR PROVIDED UNDER THE SUPERVISION OF EXHIBITOR

**RESPOINSBILITIES**: EXHIBITOR shall be responsible for the performance of labour under this section. It is the responsibility of EXHIBITOR to supervise labour secured through DEG in a reasonable manner as to prevent bodily injury and/or property damage and also to direct them to work in a manner that is in compliance with DEG Safe Work Rules and or Province, Country and Local ordinances, rules and/or regulations, including but not limited to Show or Facility Management Rules and/or Regulations. It is the responsibility of EXHIBITOR to check in with the Service Desk to pick-up labour and to return to the Service Desk to release labour when the work is completed.

**IMDEMNIFICATION**: EXHIBITOR agrees to indemnify, hold harmless, and defend DEG from and against all demands, claims, causes of action, fines, penalties, damages, liabilities, judgments, and expenses (including but not limited to reasonable attorney's fees and investigation costs) for bodily injury, including any injury to DEG employees, and/or property damage arising out of work performed by labour provided by DEG but supervised by EXHIBITOR. Further, EXHBITOR, indemnification of DEG includes any and all violations of Province, County or Local ordinance. "Show Regulations and/or Rules" as published and/or set forth by facility or show management and/or directing labour provided by DEG to work in a manner that violates any of the above rules, regulations, and/or ordinances.
